-Two (2) separate responsible contacts must be included, one of whom may be the WA National Federation contact person or secretary in the case of being directly under the NMF.

-Under the WMA Constitution, ALL Members must be a part of World Athletics Federated body (NMF) where there is an Independent committee/commission the details in 1, 2, 3 must be supplied. And a signature from the National Federation must be included.

-Where Members are only part of the Federation, at least the Secretary of the National Federation and the Masters contact person shall be required, with a letter of Approval from the World Athletics Federated body (NMF).

-WMA shall require a copy of the Constitution and a copy of the make-up of the Committee/Commission for the Member looking to affiliate. To be sent separately.

AFFILIATION or RE-AFFILIATION to WMA (“Monaco”) IMPORTANT INFORMATION:

1. The affiliation/membership is free of charge. All applicants must be a part of the World Athletics National Member Federation (NMF) either directly under the NMF or approved as a Committee /Commission of the NMF.

2. Membership of WMA shall not be available to any prospective member whose constitution is inconsistent with the Objects or spirit of the WMA.

3. Applications for Membership shall be sent to the Regional Association to which the applicant belongs, which will then provide its comments on the application and forward it to the WMA Secretary for a decision by the WMA Council.

4. Applications from the NMF in countries where there is no existing WMA Member, are automatically accepted.
5. Applications from a Masters Association authorized in writing from their NMF in countries where there is no existing WMA Member will be accepted, subject to status within the NMF.
6. Applications from standing Member are automatically accepted. If an application from the same country is presented by the NMF, or a Masters association authorized in writing by the NMF.
7. WMA warmly recommends eventual applicants not officially recognized by their NMF, to contact it before presenting their affiliation form.
8. All those duly filling up the application form and responding to all WMA constitutional requirements will get in return a confirmation of the validity of the affiliation, a complimentary copy of “any” WMA Handbook, and a statement regarding the number of voting delegates they are entitled to at the next General Assembly.

They are also entitled to regularly receive from the WMA Secretary information on the activity, reports of meetings, agenda, and directions to participate in the General Assembly.
9. The signature on the affiliation and the status of the WMA Member implies full knowledge and acceptance of the WMA rules and by laws.
